6:34pm – Call to order by President Spivey

- All teams in attendance with the exception of Yelm, Eatonville and Rainer

Old Business:

Second vote to have a true 2nd and true 4th at Sub-Division added into the by-laws

- All in favor with the exception of Orting, Olympia, and Bethel. No vote casted by Yelm, Eatonville and Rainer due to their absence.
- Total: 14 yes, 3 no, 3 n/a, amendment PASSES

Auburn's Backlash Tournament

- A success in that it was able to be ran adjacent to Rising Star tournament that had to be moved due to covid/facility issues.
- Idea brought up to run both Division tournaments at same facility and run the Backlash Tournament after, makings for a large event
- Votes not in favor for large event
- Idea brought up to run a smaller tournament
- Votes were in favor for smaller tournament
- Kirk will work out details and present options and updates

New Business:

Possible Hoquiam team wanting to join PCJWL next season

- Representatives: Jason, athletic director and Joe, Harbor Hawks Freestyle Club Head coach
- Have 14-18 Hoquiam area kids wrestling for Montesano
- Have a possible 30 kids they can pull together
- Has practice facilities and mat space
- Ability to host tournaments
- Asked to leave so that the board can deliberate amongst ourselves
- After deliberation, the league went to a vote NOT in favor of Hoquiam team
- Vote Total: 6 yes, 9 no, NO to entering league for 2022-2023 season
- Hoquiam representative brought back into room and received verdict. Was asked to petition again next year if interested, with a roster of 50+ kids to show club ability to conjure up a team.

Justin Rowland push to have more volunteerism amongst teams to provide officials/referees

- Wants to organize possible training for safety/safety training amongst teams
- Wants more consistency with calls for near fall, out of bounds, stalling and starting position

- Push to have more certified officials
- Wants to make sure that every team has a minimum of one registered referee

Final/Closing points:

For Teams

- Teams must update Point of Contact within the PCJWL website
- Teams must ensure all documents are filled out per/child for roster information. All documents located on PCJWL website
- By next year PCJWL will become more and more electronic, with the idea that it will streamline efficiency with information gathering, payments and tracking
