Opening:

Old Business:

Revisited Behavioral Issues that happened throughout this season.

- Issues with Coaches and Dads
- Teams are to start controlling their parents or the board will have no choice to start implementing punishments, which includes the coaches. This will result in missing the next event, and if the parent doesn't have a coach's card, they will be banded for 1 year.

Reviewed the \$20.00 wrestler fee.

Discussed the \$1.00 per wrestler fee

Reminded the teams, that the league pays for all the Track Wrestling fees

Discussed - No need to request officials for the JV and Exhibition Duals – Teams will provide.

New Business:

Moving into the next season at all PCWJL events, all persons on the mat must have a wrist band. The board will take care of ordering/purchasing/ distributing the wrist bands at the beginning of the next season.

Starting 2018 Season, Varsity Duals will be \$5.00 per wrestler fee, and the hosting team will get to keep the money.

Discussed raising league dues to \$650.00, to cover paying for the Track Wrestling Fees, and eliminate the \$1.00 per wrestler fee. This was approved and will start at the beginning of 2018 Season. This however, does NOT include the Tough Guy Tour.

Discussed Tough Guy Awards – WR pay to have a mold made, and can host for 2 years, through the 2018-2019 Season, to help recover costs.

Discussed putting Vashon on a 1 yr probation because they don't communicate with other teams, to let them know they aren't coming. At this time no team is on probation.

Reminded all teams that they need to send an email to PCWJL@gmail.com, with updates of any sort. New Coaches, New Board, Email, Phone number. It is the team's responsibility to make sure this is updated and accurate on the website.

Discussed What Jesse Torres needs sent to him every year. Jesse stated read the bylaws for the completion of the Roster, and send in required information.

Vote was taken for Suspending a parent or coach for and "Flagrant Behavior", starting next season. The suspension will be for 1 calendar year. This was approved by all teams, and the board.

Tahoma will be hosting league for the 2018-2018 Season.

Remind all teams to make sure to pay their official bills.
