Reminded teams of punishment rules for bad behavior of wrestlers and/or coaches/parents.

#### New Business:

Voted to have all future PCJWL meetings to be held at the Ram on South Hill, in Puyallup, same time.

Discussed the issues' with Seattle Officials, and their requests. PCJWL will not pay for their L&I insurance fees', that they are requesting. This was voted on, and All in Favor of not using them in the future. Darryl will notify them of the leagues/teams decision.

Discussed the 3 weight ins' that is required to move on to post season. Kids can go to the nearest event for their weight in, even if they are not wrestling at that event, due to football season.
